



# Pool Liner Limited PRO-RATA Warranty

AquaEZ ("Warrantor") agrees, at it's option, to replace or repair, but without installation, FOB it's factory, any liner which separates at its seam or seams, during the appropriate warranty period as noted below, from the date of sale by the Warrantor. Subject to the provisions of the then current warranty claims procedure.

If repair or replacement is so required, then the Warrantor will, at their option replace or repair the liner at the price to the end user, determined by the following scale, representing the percentage of the list prices current at time of repair or replacement, and according to the appropriate category.



## Fifteen Year Pro-Rata Schedule

### First Year Full Warranty

1 to 2 years 10%	8 to 9 years 70%
2 to 3 years 20%	9 to 10 years 75%
3 to 4 years 30%	10 to 11 years 80%
4 to 5 years 40%	11 to 12 years 85%
5 to 6 years 50%	12 to 13 years 90%
6 to 7 years 60%	13 to 14 years 95%
7 to 8 years 65%	14 to 15 years 98%

Consumer pays the above stated percentage of the retail price of the replacement pool liner.

Proof of purchase must be presented with any claim.

Date of purchase \_\_\_\_\_

The owner must notify the Warrantor in writing of the date when such failure was first noticed, within ten (10) days of the date thereof, so that the Warrantor may have an opportunity to verify the said claim and to determine whether it is within the provisions of this warranty;

(a) The failure in the seam or seams, which is subject matter of this warranty, shall be the sole defect in the liner;

(b) The failure in the seam or seams must be caused solely by a defect in the material or improper workmanship in its manufacture.

(c) A puncture or a tear immediately above or below the actual seam weld is not usually the result of a manufacturing or material defect; it is usually due to one of the following causes: improper installation, excessive water pressure, vandalism. This type of puncture or tear is specifically not covered by this warranty.

Defects caused by fire, cutting or any mechanical, chemical, termites, rot grass or other means or agencies are excluded from this warranty. The Warrantor shall, in no event, be liable for consequential damages of contingent liabilities arising out of the failure of any product or its accessories to operate properly.

This warranty excludes all other implied or statutory warranties upon which this liner is sold. It is further agreed and understood that the Warrantor's liability shall be limited to the agreement to repair or replace the liner as aforesaid, all other damages, whether proximate or not, and warranties, statutory, implied or otherwise, being hereby expressly waived by the purchaser.
